PUBLIC OUTREACH CHAIR:

Committee of four people. Will ask at least one other person to join. Ginny, Lovina, Mary B. and Mary Beth. Will discuss how to spend \$1000 that's approved. Two ideas, one is bumper stickers designed and made, can give them away or sell them. Another idea is having the bumper stickers be magnetized. Will get multiple quotes for pricing. Another idea is possibility of billboards. Discussed also putting together packets for health fairs. Committee will meet with discuss proposals.

IG COMMUNICATIONS CHAIR/WEBSITE:

Kirsten/Barb met with Lee Media and discussed updates/fixes needed. Requested new estimate, including security and advertising. Lee Media has quoted \$125/hour for training for 2+ people and possibility of learning SEO (search engine optimization). We will utilize some of the \$1000 that has already been voted on to do training for the website.

OLD BUSINESS: Continue looking for members in your home group to consider service either as R4 secretary or MCIG Region 4 Rep. (6 months abstinence requirement).

NEW BUSINESS:

Kirsten G. has agreed to serve on the website, which under our bylaws, falls under the PO chair. Please use the website. Please note what can you do there and what you can NOT do that you need/want to do and report those issues to Barb or Kirsten. On the website, there is a menu item called Intergroup with items that are PW protected. Bylaws have been added to the website. Officers/chairs have also been updated, and meeting information for the IG has been updated to state phone only. Kirsten will be responding to people who login for the first time so that they can get in and help those who need to reset their PW's.

INTERGROUP RENEWAL: Barb went to IG Renewal hosted by Reg4. This event looked at the health of OA by asking "Am I personally doing everything I can? Am I living the program and passing on the gift to others who suffer from the disease? Are we as an intergroup doing everything we can to help our members strengthen their recovery and meetings? To help keep OA strong and growing? To spread the word?" The results from Don's surveys indicate OA is

struggling. Don stated that Intergroups are the only part of our structure that can quickly provide opportunities for grassroots change (Regions and World Service are invisible to the average member). He suggested that intergroups become a training organization to supplement more recovery in members. First, Don suggested each of us look at our own recovery. He used this: Recovery (you) + Passion (you) + leadership (you) + process (I'll show you) = Intergroup renewal and OA Revitalization. He believes Intergroup's greatest service is to show people how to strengthen their personal recovery. Show people how to work the program. The new intergroup would have a vision of helping, serving, attracting and strengthening. This would be done by creating training/educational activities and opportunities to help members recover or strengthen their recovery, supplement sponsorship, help close sponsor gap. Complete ongoing IG admin tasks, and train/teach/assist meetings. For Intergroup, Usefulness is our main product. There is much more to consider that Don spoke to. For tonight, I wanted to bring this much to our attention, and suggest that we begin the process with hosting a training workshop either by zoom or in person in the summer of 2021, led by our Region 4 chair, Mary C and our Region 4 trustee, Meg. They have requested we hold this workshop in conjunction with Greater KC, Sunflower and Greater Ozarks intergroups. Discussion was held and there was no objection to August, the month R4 suggested. Discussed what topic would we be interested in having them present, and 12th Step Within was brought forth.

Our Region 4 chair, Mary C, and trustee, Meg M, plan to attend our June 8, 2021 MCIG meeting. We may meet via zoom using the new Region 4 zoom account. No one responded negatively to the question of is there anyone who would be unable to access zoom on a computer, smart phone, or laptop. As the chair had mentioned at February intergroup meeting, Don also suggested the format used for the Feb meeting to keep the business part of the meeting strong, but less time consuming. So, in the areas where the chair can, they will just ask if there are any questions/concerns and if none are heard, the chair declares the item "adopted, accepted, adjourned". If anyone has any questions or issues with using this form of parliamentary procedure on any item, please speak up and we will discuss/use motions/call for a vote.

Susan W has started an OA meeting where there have been a couple members attend with her in Ashland, KS. The meeting is Friday at 11a.m. Barb has joined them a few times. Susan would appreciate other members who can call into her personal phone number and help her to continue the meeting. Barb can provide her phone number to anyone willing to call in or it is on the Sign-in form emailed with the agenda. You may give this information to your home meetings also! A great way to reach out to still suffering compulsive eaters, and help a recovering member keep a meeting open.
