On January 31, Linda and Windy set up a table at the Women's Recovery Event. This event was for women in many 12 Step fellowships and gave OA exposure to those who didn't know about our organization.

On February 2 William met with 30 Dental Hygiene students and 2 faculty members at WSU to share professional information packets as well as his own personal experience.

Two of our members are currently working on creating handouts with our meeting information and website information to have at public outreach events and to display in other 12 step rooms.

We have 2 upcoming events that we will need volunteers for. The first event is the WSU Health Fair at the Heskett Center on March 4th from 11:30-1pm. The second is the Wichita Women's Fair.
